## Notice of Intent to Provide Home Instruction

I am providing notice of my intent (NOI) to provide home instruction for the child(ren) listed below as provided by VA Code § 22.1-254.1 in lieu of attending school for the school year 20\_\_ - 20\_\_. *Note: This form is provided for your convenience only. You may use any NOI.*

### HOME INSTRUCTION OPTION

I am eligible to provide home instruction for the above children as indicated below. (Check **only one** option below.)

- 1. I have a high school diploma or college degree. A GED is not acceptable for this option.**  
⇒ Attach a copy of your diploma, degree, or transcript. KGCS does NOT maintain this record and it must be submitted annually.
- 2. I have the qualifications prescribed by the Virginia Board of Education for a teacher.**  
⇒ Attach a copy of your current Virginia teaching certificate. KGCS does NOT maintain this record and it must be submitted annually.
- 3. I have provided my child(ren) with a program of study or curriculum which is delivered through a correspondence course, distance learning program, or in any other manner.**  
⇒ Attach evidence of enrollment showing child's name, name and address of the program, and enrollment date (if applicable).
- 4. I have attached a statement which describes why I am able to provide an adequate education for my child(ren).**

### SUPPORTING DOCUMENTATION

I have included **both** of the following with this NOI (please include your child's name on each document to ensure it can be identified):

- a description of the curriculum, limited to a list of subjects to be studied during the coming school year;
- **AND** evidence of having met criteria for the selected option (#'s 1 through 4) as indicated above.

### DEADLINES

Notice of Intent: NOI and supporting documents are due annually by August 15. School divisions are obligated to follow up with families in regards to potential truancy cases in accordance with VA Code, including but not limited to § 22.1-261, § 22.1-260, § 22.1-258, § 16.1-278.5.

Evidence of Progress: Evidence of adequate progress is due annually by August 1 following this school year for each child listed above between the ages of six (on or before September 30 of this school year) and 18 who has not graduated or obtained a high school diploma. Once a child turns 18, they are no longer under the compulsory attendance code.

### PROBATION

If evidence of adequate progress is not provided as required by VA Code §22.1-254.1(C), the home instruction program for that child may be placed on probation. When in probationary status, parents must submit evidence of their ability to provide an adequate education and a remediation plan addressing any educational deficiencies. If the plan is accepted, home instruction may continue for one probationary year. If the plan is not accepted or satisfactory evidence of progress is not provided by August 1 following the probationary year, home instruction shall cease.
